By signing this contract and entering your credit card information in the appropriate fields you are authorizing Millenium Limo, Inc. To charge the credit card for any of the following charges; deposit, cancellation fee, damages to the vehicles, and all services rendered. We will calculate the exact amount of hours and charges when the trip is completed. We will then deduct your deposit amount leaving the actual balance due.

**Limousine Rules and Regulations:**

- 1. No alcohol consumed by anyone less than 21 years of age. Violation may result in early termination, no refunds.
- 2. No Smoking inside limousine, \$200.00 charges per incident. No exceptions.
- 3. \$250 clean-up fee for vomit in the limousine.
- 5. \$20.00 per broken or missing glasses.
- 6. \$100.00 clean up fee for excessive matter in limousine.
- 7. All unruly persons will be dropped of at the sole discretion of the driver (no refund given)
- 8. We will not be responsible for any lost, damaged, or stolen property.
- 9. No illegal drug use of any kind.
- 10. Overtime will be billed in one hour increments. (10 minutes after each hour no exceptions)
- 11. Cancellations must be made in writing by certified mail within 14 days of your scheduled event to avoid being billed the full contract price. For national events like Super Bowl, Pro Bowl, Music Awards, etc..., all cancellation must be made 30 days in advance by certified mail to avoid being charged the full amount
- 12. Customer agrees that overtime will be billed at the contracted rate and agrees to pay any overtime charges.
- 13. Customer agrees that replacement Limousine or color may be substituted if contracted Limousine becomes unavailable for any reason. In case we do not have the replacement vehicle, Millenium Limo will farm out the service to a reputable company.
- 14. All entertainment including CDs, DVDs, VHS tapes is to be provided by the client. In case any of the electronics in the vehicle are not functional, for example the PS 2 or IPOD, we will not make any discount on the hourly. All electronics are provided at no extra cost, so the functionality is not calculated on the hourly of the vehicle
- 15. Emergency Exit or Sun Roof is to remain closed at all times. If the Sun Roof flies off due to a passenger opening it, A charge of \$700.00 will be billed the credit card below, no exception.
- 16. No videos or photos recorded during the use of the limos will be used for public viewing without the written Consent of Millenium Limo, Inc.
- 17. 25% Gratuity is automatically added to the price, along with any SPC charges (15%).
- 18- All jobs will be charged a non refundable \$250 deposit per limo booked
- 19. We do not guarantee color of limousine, we take requests only.
- 20. Excessive amount of driving will incur additional charges. Any vehicles booked 45 miles from the home office will incur a drive time of 1 hour plus any additional excessive driving of 20 miles per hour. Any miles over the minimum will incur and Additional \$3.00 per mile over the hourly quoted.
- 21. On all proms and Homecoming, we will not allow anyone to use the vehicle while the dance or function is taken place unless Prior arrangements are made with the office. Please keep in mind that additional charges will apply.
- 22 The start time and end time is for internal use only for drivers and office records.

Contract obligations: I understand and agree to the length and usage along with any charges and further agree to pay for any and all damages my party may cause during the rental periods. I also agree to the above Limousine Rules and Regulations. All damages are the sole discretion of the driver. I understand and agree to pay the entire contract price if cancellation is not allowed. The number of hours you agree to on the contract is the minimum hour customer agrees to pay. I understand that I am giving up my right to make claims or file lawsuits against Millenium Limo, Inc for Injuries and other damages which may occur while I use the Limo. I am signing this release freely and of my own accord, realizing that it is binding upon myself, my heirs, my personal representative and assigns. In the event that I am signing this release on behalf of any minors, I represent that I have full authority to do so, realizing its biding effect on them as well as myself.
